- b) Invite interested persons and the public to submit comments on the Facilitator Status within **30 days** from the date of this publication.



## **B-BBEE FACILITATOR STATUS**

The Codes state that in calculating their Ownership score, an entity must treat B-BBEE Facilitators as having rights of Ownership held:

- 100% by Black people;
- 40% by Black women;
- 20% by Black designated groups;
- Without any acquisition debts; and
- Without any third-party rights.

## **TEKOM SOC LTD APPLICATION FOR B-BBEE FACILITATOR STATUS**

Telkom shall use the B-BBEE facilitator status to accelerate transformation in the ICT sector. Transformation in the ICT sector is guided by the Amended ICT Sector Code.
