INVITATION TO PARTICIPATE IN AN OUTWARD SELLING MISSION TO OSLO NORWAY AND COPENHAGEN, DENMARK FROM 11 TO 15 NOVEMBER 2019

The Department of Trade and Industry (**the dti**) invites you to apply to participate in an Outward Selling Mission (OSM) to Oslo, Norway and Copenhagen, Denmark, which is scheduled to take place from 11 to 15 November 2019. The objective of this mission is to facilitate access for South African value-added products and services into the Scandinavian countries.

The mission to Norway will coincide with the annual E – Health Conference, taking place from 12 – 13 November 2019 in Oslo. This conference is founded by the Ministry of Health and Care Services together with ICT Norway, targeting the digitization of the health sector; with a focus on national strategy, security, welfare technology, privacy, health data, digital pharmaceuticals, techno-revolution, health design and innovation. Approved and related companies will have the option of attending this event at their own cost.

The targeted sectors for this mission include:

- Technology and Services;
- Clean Tech (waste, water, renewable energy);
- Electro-technical Equipment and Services;
- Ocean Economy (Aquaculture and Oil and Gas).

Companies will be screened and selected in line with the EMIA guidelines and market requirements.

For the approved companies, **the dti** will provide:

- Accommodation up to a maximum of R3,000.00 per night (bed and breakfast only);
- An economy class return airfare up to a maximum of R17,000.00; and
- Transport of samples up to a maximum of R2000, 00.

Companies applying for EMIA funding for this mission need to complete and submit the EMIA application form and supporting documentation.
